Describe the aims; objectives and purpose of the strategy/policy/function/ service (include how it fits in to wider aims or strategic objectives).	<p>In order to make budget savings relating to the expenditure of the District Council, there are proposed reductions to the capital programme by removing various transportation related schemes. The schemes affected are the Market Town Transport Strategies, Safe Cycle Routes, Local Transport Plan Bid, Bus Shelter Provision & Railway Station Improvements</p> <p>These budget headings have provided in the past to provide partnership funding to a range of schemes and maximise scheme delivery on the ground. The main partner has been the County Council in their role as local highway authority. Schemes have included cycling and walking improvements, public transport related initiatives inc. information and bus shelter provision as well as local rural initiatives such as lay-by and parking provision, particularly in partnership with Parish Council's. The overall impact will be evenly spread across the community and users of these particular facilities and it is not considered that older people, children</p>



	or those with disabilities would be prejudiced more adversely than any other section of the community.
Are there any (existing) equality objectives of the strategy/policy or function/ service	There are no existing equality objectives but some of the outcomes from a reduction in the capital schemes may have a greater impact to certain groups i.e. those who use public transport and those who cycle and walk to a greater degree.
